WBAGI Awareness Roadshows

The building of a proposed 350,000 tonne waste incinerator on a designated area of outstanding natural beauty (AONB) at Old Kiln Farm, Curridge / Chieveley will have an impact on all our surrounding villages. The massive three 45 metre high buildings and the two 75 metre high chimneys will be clearly visible from miles around and will dominate the landscape.

Hermitage will be directly upwind and the proposed development is within the designated Hermitage Wooded Commons area which has special mention for conservation in the AONB's Landscape Assessment plans.

Cold Ash and Ashmore Green, not directly under the protection of the AONB, will see a precedent being set and perhaps see its own countryside

at risk of future developments. Indeed any area within West Berkshire that today is a greenfield site will be at risk of industrial development should this proposal go ahead.

The general desirability of the area as a whole will be severely impacted and the additional 400 lorry movements a day to the area will also impact our daily lives.

WBAGI have launched a series of village roadshow events to help spread the word and raise awareness.

Hermitage hosted the first road show on April 2nd with invitations extended to residents of Hampstead Norreys and Oare.

Grundon Quarry Extension Planning Application

Hundreds of objections lodged against Grundon's planning application

Grundon's application to extend their quarrying activity to a further 51 acres of land within the Area of Outstanding Natural Beauty (AONB) was submitted in early March. By the 25th March around 500 letters of objection had been lodged with West Berkshire Planning, including objections from the AONB organisation, the WBAGI appointed legal advisor who has extensive experience in this area, the MOD, Natural England, Chieveley Parish Council, Peasemore Parish Council and West Berkshire Ramblers.

The WBAGI legal advisor has focussed on this AONB area not having any exceptional characteristics with regards to quality or quantity of sand within it.

"There is nothing special about the need for building sand extraction in the AONB or in relation to the characteristics of the application site. Indeed there is a fundamental concern that the application site is of such poor quality and yield as to hardly be described as mineral bearing in a building sand sense."

The North Wessex Downs AONB's key objection is that:-

"This proposal will result in a major development that will result in increased intrusion and loss of the special qualities that make up the character of the AONB and therefore this proposal fails to meet the objectives of the North Wessex Downs Management Plan 2009-14..... to conserve and enhance its quiet, secluded character."

We thank you all for lodging your objections to this application.

The next stage will be for this application to be reviewed at a full West Berkshire Planning Committee meeting, expected sometime after Easter.
